

HUD Manufactured Housing INITIAL & CONTINUING EDUCATION Installer Training

Meet the Instructor

Installation trainer Philip Sailor is a manufactured housing industry veteran, having started in 1985 with a major manufacturer. He has worked in manufacturing, training, design approval and regulatory roles.

Early on, he recognized that installers were not receiving installation instructions that were clear and easily-understood, so he approached the issue in three ways. He served as a resource for installers and local inspection authorities so they could have their concerns addressed in a timely manner, he provided training to installation inspectors, and he worked with his corporate engineering staff to help revise installation instructions for clarity.

Phil has inspected installations in more than a dozen states to assist manufacturers, retailers, installers, attorneys, State Administrative Agencies, and the U.S. Department of Housing and Urban Development.



IMPORTANT NOTE: HUD licensed installers are required to renew their license every 3 years. Continuing Education training can be completed anytime prior to the renewal.

HUD Manufactured Housing INITIAL & Continuing Education Installer Training

February 15 & 16, 2023—This 12-hour HUD approved training will discuss the proper installation of new manufactured homes, record keeping and other installer responsibilities as they relate to the HUD Administered Manufactured Home Installation Program.

Successful participants will have satisfied the **INITIAL** training requirement for the HUD issued installer license when they have completed both days and successfully passed the exam.

CONTINUING EDUCATION:

Once licensed, the HUD Installer License must be renewed every 3 years. In order to renew, the HUD-licensed installer must take 8 hours of approved continuing education. Participation in any of the one day continuing education classes listed will meet the requirements for licensed HUD installers renewal. Please remember you will need to submit proof of completion of a continuing education class and your renewal application at least 60 days prior to license expiration.
